Also an undertaking be furnished along with the periodical statement that no security personnel are engaged in any place other than the place of deployment submitted in the statement and adhering to the provisions of the Act as mentioned in the schedule of the Private Security Agencies (Regulation) Act, 2005.

CONDITIONS

1. This license is granted subject to all provisions of the Private Security Agencies (Regulation) Act, 2005 and Odisha Private Security Agencies Rules, 2009.
2. The licensee shall, within six months of obtaining the license, commence its activities.
3. The licensee shall successfully undergo a training relating to the private security service as prescribed by the Controlling Authority within the timeframe fixed by it.
4. The licensee shall be satisfied about the character and antecedents of every security guard/ supervisor before engaging them as per Rule-4 of the Odisha Private Security Agencies Rules, 2009.
5. The licensee shall ensure that guards and supervisors successfully undergo the training as indicated under Rule-5 of the Odisha Private Security Agencies Rules, 2009.
6. The licensee shall, within sixty days from the date of issue of the license, employ required number of supervisors as provided under Rule-7 of the Odisha Private Security Agencies Rules, 2009.
7. The licensee shall ensure that every Private Security Guard working for it, undergoes a medical examination after every twelve months from his last such examination so as to ensure his continued maintenance of physical standard as prescribed in the entry level.
8. The licensee shall immediately intimate the Controlling Authority regarding any change in the address of persons forming the Agency, change of management etc. within seven days of such change.
9. The licensee shall immediately intimate to the Controlling Authority about any criminal charge framed against the persons forming the agency or against the security guard or supervisors engaged or employed by the agency, in the course of their performance of their duties. A copy of such communication shall also be sent to the Officer-in-Charge of the Police Station where the person charged against resides.
10. The licensee shall abide by the requirements of Physical Standards for the security guards and their training as prescribed in the Odisha Private Security Agencies Rules, 2009 as the condition on which the license is granted.
11. The licensee shall issue photo identity cards to the employees of the agency in Form-IX of the Rules.
12. The licensee shall issue a uniform and make it obligatory for its security guards and supervisors to wear the uniform while on duty.
The licensee will also make obligatory to put on:
 - a. An arm badge distinguishing the agency
 - b. Shoulder or chest badge to indicate his position in the organisation
 - c. Whistle attached to the whistle chord and to be kept in the left pocket
 - d. Shoes with eyelets and laces
 - e. A headgear which may also carry the distinguishing mark of the agency
13. The uniform used by the Private Security Guards shall not resemble the uniforms of the Armed Forces or the Para-Military Forces or the Police.
14. Every Private Security Guard while on active security duty will wear and display the Photo Identity Card issued under Section 17 of the Act on the outermost garment above waist level in a conspicuous manner.
15. The licensee shall maintain a register containing all the details regarding the persons managing the agency, the employees and clients of the agency as per section 15(1) of the Private Security Agencies (Regulation) Act, 2005.
16. Rules & Regulations as per Arms Act should be strictly followed regarding possession of fire arms & weapons.
17. Whenever any information is called for, it is the duty of the licensee, Supervisor, or private security guards to provide the information as per Section 15(2) of the above Act.
18. The Licensing Authority or any other Officer authorised by him may inspect the premises and verify the documents and records of the Licensee any time.
19. The Security Agencies shall obey the provisions of the Act scrupulously.
20. The Security Guards can't carry arms unless specifically issued with the Arms License.
21. The licensee shall follow the syllabus as envisaged in Rule-5 of Odisha Private Security Agencies Rules, 2009 scrupulously.
22. Any violation of the above conditions and other provisions of the Act, 2005 and Rules, 2009, the license can be cancelled/ suspended as per Sec.13 of the PSA(R) Act, 2005
23. In the event of the Directors/Partners issued with the license ceases to be the Director/Partner, the agency should apply in Form-V alongwith Form-I for transfer of license in favour of the new Director/Partner.
